  - County Line Booths: 50 cents sq ft.
  - Under covered and lighted arena - 50 cents sq feet

## Reserve Your Booth

Booths for the 2016 Lincoln County Wildlife Expo can be reserved immediately. Booth locations are on a first come first served basis. A non-refundable 50% deposit is required within 10 working days from the time of when you make your reservation. Exhibitor contract is included in this packet. You may send in a completed contract along with the deposit. Phone calls are accepted to reserve a space but again, we must receive your contract and deposit within 10 working days. Remaining balances will be due August 11, 2016. If reserving only by mail, please mark your top three location choices, enclose your payment and contract, and mail to the LCC. ## **Driving Directions:**

### **From the north:**

Take I-55 South to North Brookhaven Exit 42. Turn left onto Union Street Ext. Continue to follow Union Street Ext. NE. Turn left onto Industrial Park Road NE. Industrial Park NE becomes Beltline Drive. Turn left into the Lincoln Civic Center.

### **From the South:**

Take I-55 North to North Brookhaven Exit 42 towards Industrial Park. Turn Right onto Union Street Ext. Continue to follow Union Street Ext. NE. Turn left onto Industrial Park Road NE. Industrial Park NE becomes Beltline Drive. Turn left into the Lincoln Civic Center.

### **From the West:**

Take HWY 84 East to Brookhaven. Turn left onto HWY 51 North. Turn right onto Industrial Park Road NE. . Industrial Park NE becomes Beltline Drive. Turn left into the Lincoln Civic Center.

### **From the East:**

Take HWY 84 West to Brookhaven. Turn right onto HWY 51 North. Turn right onto Industrial Park Road NE. . Industrial Park NE becomes Beltline Drive. Turn left into the Lincoln Civic Center.
