## AFTER-HOURS CONTRACT

### KNOW ALL MEN BY THESE PRESENTS:

\_\_\_\_\_, Tel: \_\_\_\_\_, a LINCOLN CIVIC CENTER Equine Association member of good standing and in accord with the privileges of membership thereof, and does herein contract to be the Equine Association member responsible for the after-hour usage of the arena of the LINCOLN CIVIC CENTER.

Said contracting Equine Association member contracts and agrees as follows:

1. The Equine Association member agrees that "After-Hours" usage of the arena is a privilege of membership in good standing and is available only on those days when the arena is not booked for special events;
2. The Equine Association member agrees that "After-Hours" usage of the arena is a privilege of membership that is fee-free between the hours of 5:00 p.m. and dark when pre-arrangements are made through "After-Hours" Contracts;
3. The Equine Association member agrees that he/she will be the responsible party for care of the facility while the premises is in "After-Hours" use;
4. The Equine Association member agrees that he/she will be the responsible party for turning off the arena lights (if contracted for) and locking the facility gate(s) at the termination of the "After-Hours" use, and that failure to do so will revoke the arena "After-Hours" usage privilege for that member;
5. The Equine Association member agrees that should he/she desire to utilize the arena after dark, a light fee of sixty dollars (\$60.00) will apply and will be paid at the time of signing this contract. Payment of the \$60.00 light fee will entitle the member to arena-lights usage from dark until midnight;
6. The Equine Association member agrees that the scheduled discipline of the day, as listed on the Equine Association Riding Schedule, has preference to schedule "After-Hours" use until 12:00 p.m. of the scheduled discipline day;
7. The Equine Association member agrees that after 12:00 p.m., and under the condition that no Equine Association member has scheduled "After-Hours" arena usage in conjunction with the discipline of the day, then scheduling "After-Hours" usage of the arena for any discipline is on a first-come-first serve basis;
8. The Equine Association member agrees that his/her visitors or guests are allowed a one-time-only usage of the arena during an After-Hours Contract, and agrees to pre-notify LINCOLN CIVIC CENTER management of the visitors/guests at the time of making the "After-Hours Contract";
9. The Equine Association member agrees that executing this After-Hours Contract for the period of time between 5:00 p.m. and dark, does not entitle him/her to exclusive usage of the arena for this period of time to the exclusion of any/all other Equine Association members of the scheduled discipline of the day;
10. The Equine Association member agrees that executing this After-Hours Contract for the period of time post-dark, and paying the \$60.00 light fee does entitle him/her to the exclusive usage of the arena for this period of time to the exclusion of any/all other Equine Association members, if they so desire. However, the Equine Association member agrees to accommodate other members usage of the arena for this period should they offer to share the lights fee;
